**Carol** has received correspondence from the ACU putting forward options for the forthcoming on-line licence system. After some discussion it was decided that the club would support Option 2 whereby the Club's Membership Secretary would have a list of randomly generated code numbers supplied by the ACU. Then, when a club member renews his annual subscription or a new member joins the club, the Membership Secretary will give them a code number which they will need to enter during the on-line application, to complete the application process and validate the licence. Clubs have until 30<sup>th</sup> June to respond to the ACU with their opinions and it is intended that the new system will be available from 1<sup>st</sup> November in plenty of time for the 2012 season.
